




Figure.: Grid Account Customer Group Details




Figure: Schematic Representation of a Gas-Specific System Landscape




Figure: Data Exchange Monitor






Data Exchange Monitor

The Data Exchange Monitor allows users to monitor gas messages received or provided by the Application Process Engine (APE), supported by SAP Fiori interfaces.

The application is divided into two sections, where data exchange processes are categorized based on receipt and transmission, as well as the status and content of the market messages.






#### **SLPASP**

The SLPASP application enables users to analyze messages in the SLPASP format.

After selecting a message, detailed information, such as SLPASP parameter values, is visualized.

Users can view optimization factors related to weekday, temperature, as well as information on residual load and the total sum of the SLP allocation.






SLP Replacement Values

The SLP Replacement Values application visualizes ALOCAT messages received from the MGV.

Process-wise, the contents of incoming messages are stored within the relevant profiles.

To assess the deviation between received messages and unsubmitted balancing results, users can perform a visual inspection.






# **Allocation Accurancy**

The SLP Allocation Accuracy application is used to determine various cumulative absolute grid account deviations and provides a graphical visualization of different scenarios for easy analysis.






**Declarations Management** 

The Declaration Management application enables users to create, analyze, and submit declaration lists for market communication.

After selecting a declaration list, users can access detailed information on time series types per balancing unit or view the transmission status.






# **Allocation Clearing**

The Allocation Clearing application allows users to execute allocation clearing processes within the framework of the Cooperation Agreement (KoV).

Users can initiate clearing, trigger the corresponding clearing balancing, and transmit the clearing allocations as part of market communication.

Additionally, detailed information regarding balancing or clearing activities is provided for each entry.






#### **Grid Account Monitor**

The Grid Account Monitor application provides a clear overview of daily grid account balances, including Saldo 0, Saldo 1, and their relative deviations.

Additionally, tolerance days are clearly marked for better tracking.






Grid Account Monitor: Balancing

The Grid Account Monitor: Balancing application provides a clear visualization of aggregated balancing volumes across various time periods, including SLP D-1, RLM D+1, RLM M+12 BB/AB, Entry, and Exit.






Grid Account Monitor: Temperature Display

The Grid Account Monitor: Temperature Display application visualizes the trend of the grid account balance in relation to the temperatures stored and applied in the system.

Additionally, it provides a comparison between forecasted and actual measured temperatures at different measurement points.

This feature enables better analysis of temperature fluctuations, assessment of temperature forecast accuracy, and a comprehensive evaluation of the relationship between temperature and grid account balance.





Grid Account Monitor: Customer Group Analysis

The application provides a clear visualization of daily SLP grid account volumes categorized by customer group.
